



Background information

Greasby Infant School will remain open for children and staff whilst also acting as a polling station for the local elections. Following a previous positive parental questionnaire, discussing the impact of using the school as a polling station whilst remaining open, the Governing Body took the decision to remain open again this year. The local authority feedback was also positive with the election staff happy to use the Technology Room rather than the School Hall, meaning that school could continue to open for pupils and staff.



The risk assessment and procedures for this year's election day have been discussed with staff and the election team, and are available on the school website for parents. These will be reviewed following the event and updated as appropriate.


