



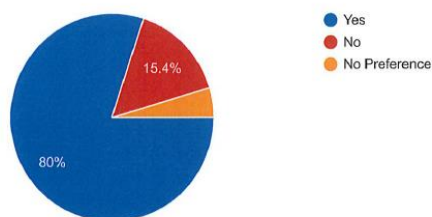

### Background information

Greasby Infant School will remain open for children and staff whilst also acting as a polling station for the local elections. Following a very positive parental questionnaire last year, discussing the impact of using the school as a polling station whilst remaining open, the Governing Body took the decision to remain open again this year. The local authority feedback was also positive with the election staff happy to use the Technology Room rather than the School Hall, meaning that school could continue to open for pupils and staff.

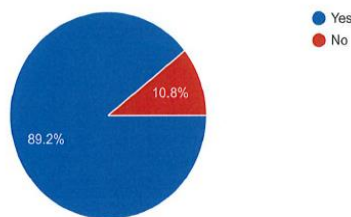
Do you think the school should have remained open for children on Thursday, 6th May?

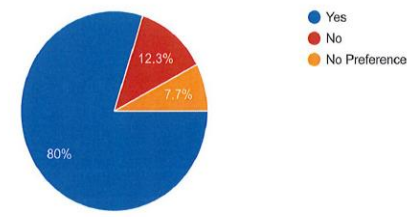
Did you receive enough information about the plans for election day?
